

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

# ARTICLE I.

The name of the corporation is FundsXpress, Inc.

#### ARTICLE II.

The following amendment to the corporation's Articles of Incorporation was adopted by the shareholders of the corporation on September 28, 1999.

ARTICLE ONE of the Articles of Incorporation is amended and restated to read as follows:

#### "ARTICLE ONE

#### <u>Name</u>

The name of the corporation is FundsXpress Financial Network, Inc."

#### ARTICLE III.

The number of shares of the corporation outstanding at the time of such adoption was 10,229,440 shares of Common Stock and no shares of Preferred Stock; and the number of shares entitled to vote thereon was 10,229,440.
