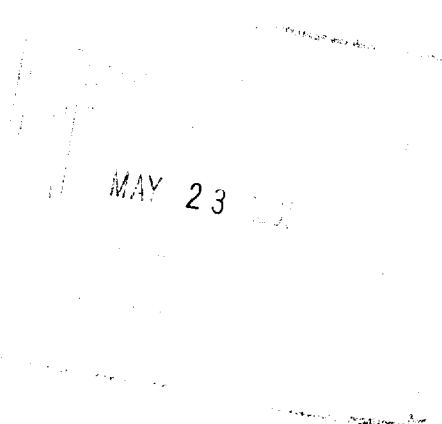



Whereas Pure Spirit Productions, of Middleburg Heights, is desirous of acquiring said mark and the registration thereof; CLAIRE'S FOLLY


