The name of the corporation is American Plywood Association.

On October 11, 1994, the members of American Plywood Association adopted the following amendment to the Articles of Incorporation of American Plywood Association, amending said Articles of Incorporation to read as follows:

Article I. The name of this corporation shall be *APA – The Engineered Wood Association*.

Article II. The purposes of this corporation are to conduct trade promotion activities including cooperative advertising and publicity; to develop a statistical service of interest to the industry; to engage in research for joint account; to own and register trademarks and also license them for use by its members at no additional charge over and above the dues provided for in the bylaws under such terms and conditions as the Board of Trustees shall fix from time to time, in their discretion, and to engage in and all lawful activities permitted corporations not formed for profit and which may tend to promote the common business interest of the engineered wood products industry and apprise the public of its scope and character.

A quorum was present at the aforementioned meeting and the vote on the amendment was unanimous.
