

ALL OF THE PERSONAL PROPERTY TRANSFERRED BY THE SALE IS ACCEPTED BY BUYER, WITHOUT RECOURSE, IN AN "AS IS" CONDITION, "WHERE IS", "WITH ALL FAULTS" AND WITHOUT ANY WARRANTIES OR REPRESENTATIONS OF ANY KIND OR NATURE, WHETHER WRITTEN OR ORAL, EXPRESSED, BY OPERATION OF LAW, OR OTHERWISE. RECEIVER MAKES NO WRITTEN OR ORAL WARRANTY OR REPRESENTATION, WHETHER EXPRESSED OR IMPLIED, AND SPECIFICALLY DISCLAIMS THE MAKING OF ANY ORAL OR WRITTEN WARRANTY OR REPRESENTATION, WHETHER EXPRESSED OR IMPLIED, THAT THE PERSONAL PROPERTY IS MERCHANTABLE OR FIT FOR A PARTICULAR PURPOSE.

RECEIVER MAKES NO REPRESENTATIONS OR WARRANTIES, EITHER EXPRESSED OR IMPLIED, CONCERNING, AND SPECIFICALLY DISCLAIMS, ANY RIGHT OR ABILITY ON THE PART OF RECEIVER TO CONVEY THE PERSONAL PROPERTY FREE AND CLEAR OF ANY LIENS AND CLAIMS. BUYER, ITS SUCCESSORS AND ASSIGNS, SHALL BE FOREVER RESPONSIBLE FOR THE PAYMENT OF ANY SALES TAX, OR OTHER TAX ASSESSED, LEVIED, OR IMPOSED IN CONNECTION WITH THE TRANSFER OF THE PERSONAL PROPERTY BY RECEIVER TO BUYER, AND BUYER, ITS SUCCESSORS AND ASSIGNS, DOES HEREBY AGREE TO INDEMNIFY AND HOLD RECEIVER HARMLESS FROM THE IMPOSITION, ASSESSMENT, LEVY, PAYMENT AND COLLECTION OF SALES TAX, OR ANY OTHER TAX, IN CONNECTION WITH THE TRANSFER BY RECEIVER OF THE PERSONAL PROPERTY.

Receiver shall have no liability or responsibility for recording or issuing any documents of title covering all or a portion of the Personal Property, or for reflecting the transfer of the right, title and interest in and to the Personal Property in any public records. All such recordations, filings, and changes to any public or private records shall be performed by Buyer at its sole discretion and at its sole expense.

Buyer hereby releases and holds Receiver harmless from any and all liability and damages arising from the removal of the Personal Property from the premises of Enjoy Foods International, located at 10601 Beech Avenue, Fontana, California.
