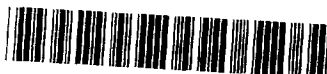


TRADEMARK ASSIGNMENT


