(Under Section 904 of the Business Corporation Law)

It is hereby certified, upon behalf of each of the constituent corporations herein named, as follows:

**FIRST:** The Board of Directors and Shareholders of each of the constituent corporations has duly adopted a plan of merger setting forth the terms and conditions of the merger of said corporations.

**SECOND:** The name of the constituent corporation, which is to be the surviving corporation, and which is hereafter sometimes referred to as the "surviving constituent corporation" is Global Computer Supplies Inc. and was originally formed under the name Global Computer Supplies International Ltd. The date upon which its Certificate of Incorporation was filed by the New York Department of State is December 14, 1984.

**THIRD:** The name of the other constituent corporation, which is being merged into the surviving corporation, and which is hereinafter sometimes referred to as the "merged constituent corporation" is Continental Dynamics Corporation. The date upon which the Certificate of Incorporation of Continental Dynamics Corporation was filed by the New York Department of State is January 2, 1963.

**FOURTH:** As to each constituent corporation, the designation and number of outstanding shares of each class and series, entitled to vote and the voting rights are as follows:


