1. That in accordance with Section 141 of the General Corporation Law of the State of Delaware, as amended (the "DGCL"), the board of directors of the Corporation, in lieu of a meeting and vote of the board of directors, approved and adopted by unanimous written consent resolutions proposing that ARTICLE ONE of the Corporation's Certificate of Incorporation be amended and restated in its entirety as set forth in Exhibit A attached hereto (the "Amendment") and recommending that the Amendment be submitted to the sole stockholder of the Corporation for its consideration and approval.
2. That in accordance with Section 228 of the DGCL, the sole stockholder of the Corporation, in lieu of a meeting and vote of the stockholders, approved and adopted by written consent a resolution authorizing the Amendment, which written consent has been filed with the Corporation.
3. That the Amendment has been duly adopted in accordance with Section 242 of the DGCL.
4. That the Amendment be effective at 12:01 a.m. on September 4, 1996.

The Corporation's Certificate of Incorporation be amended by amending and restating **ARTICLE ONE** of the Certificate of Incorporation to read in its entirety as follows:

ARTICLE ONE

The name of the corporation is **CompX International Inc.** (the "Corporation").
