TRADEMARK SECURITY AGREEMENT, dated as of May 7, 2001 (together with all amendments if any from time to time hereto, this "Trademark Security Agreement"), by and among Colorado Prime Corporation, a Delaware corporation having its principal place of business at 500 BI-County Boulevard, Suite 400, Farmingdale, New York 11735 (the "Assignor") and Dresdner Bank, A.G., New York and Grand Cayman Branches, having an office at 75 Wall Street, New York, New York 10005, as agent (in such capacity, "Agent"), for the Issuing Bank, the Agents and the several banks and other financial institutions (the "Lenders") from time to time parties to the Credit Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of May 7, 2001 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among the Assignor and Lender, Lender has agreed to make extensions of credit to the Assignor upon the terms and subject to the conditions set forth therein; and

WHEREAS, Assignor is party to a Borrower Security Agreement of event date herewith in favor of the Lender (the "Security Agreement") pursuant to which the Assignor is required to execute and deliver this Trademark Security Agreement;

WHEREAS, the parties intend for this Trademark Security Agreement to amend the Borrower Intellectual Property Security Agreement dated May 9, 1997.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and to induce the Lender to enter into the Credit Agreement and to induce the Lender to make extensions of credit to the Assignor thereunder, the Assignor hereby agrees as follows:

<u>Defined Terms</u>. Unless otherwise defined herein, terms defined in the Credit Agreement or in the Borrower Security Agreement and used herein have the meaning given to them in the Credit Agreement or the Borrower Security Agreement

Grant of Security Interest in Trademark Collateral. Assignor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of such Assignor, hereby collaterally assigns, conveys, mortgages, pledges, hypothecates, transfers and grants to the Lender, for the benefit of the Lender, a lien on and security interest in, all of its right, title and interest in, to and under the following collateral of such Assignor (the "Trademark Collateral"):

all of its trademarks and trademark licenses, service marks, service mark licenses, trademark applications, service mark applications, designs, logos, indicia, trade names, corporate names, company names, business names, fictitious business names, trade styles, elements of package or trade dress, and other source or product or service identifiers, used or associated or appurtenant to the products, services and businesses of the Assignor, to which it is a party, including those referred to on *Schedule A* hereto (collectively, "Trademarks");

all past, present or future rights in, to, and associated with Trademarks throughout the world, whether arising under federal law, state law, common law, foreign law or otherwise;
