RELEASE AND REASSIGNMENT

This **RELEASE AND REASSIGNMENT** is made this 17th day of May, 2001 by Silicon Valley Bank.

W I T N E S S E T H :

WHEREAS, Silicon Valley Bank (the "Lender") extended certain financial accommodations to Ithaca Peripherals Incorporated, a Delaware corporation ("Borrower"). As security for Borrower's obligations to Lender, Borrower granted to Lender a security interest in and to the Trademarks and Patents, as each is defined below; and

WHEREAS, instruments evidencing such security interest were recorded in the United States Patent and Trademark Office on May 18, 1992, and

WHEREAS, the financial accommodations have been fully satisfied and, therefore, Borrower has requested that Silicon Valley Bank release its security interest in the Trademarks and Patents and reassign the same to Borrower.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Silicon Valley Bank hereby releases its security interest in all of Borrower's right, title and interest in and to all of its now owned or existing and filed and hereafter acquired or arising and filed:

(a) trademarks, trademark registrations, trade names and trademark applications, including, without limitation, the trademarks and applications listed on Schedule A, attached hereto and made a part hereof, and (a) renewals and extensions thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringement thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights corresponding thereto throughout the world (all of the foregoing trademarks, trademark registrations, trade names and applications, together with the items described in clauses (a)-(d) of this subparagraph, are hereinafter referred to as the "Trademarks");

(b) patents, patent registrations, and patent applications, including, without limitation, the patents listed on Schedule A, attached hereto and made a part hereof, and (a) renewals and extensions hereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringement thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights corresponding thereto throughout the world (all of the foregoing patents, patent

registrations, and patent applications together with the items described in clauses (a)-(d) of this subparagraph, are hereinafter referred to as the "Patents");

(c) the goodwill of Borrower's business connected with and symbolized by the Trademarks.


