

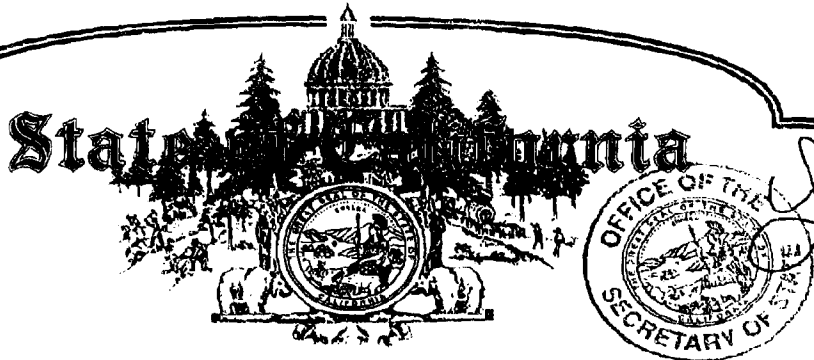

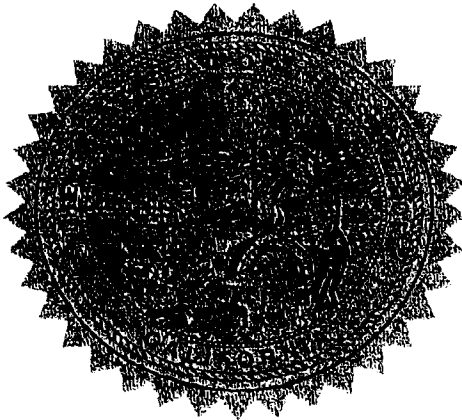

- 2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:




The name of the corporation is XIFIN, Inc."
