WHEREAS, Hoover Materials Handling Group, Inc. ("HMHGI"), a subsidiary of Hoover Group, Inc. ("HGI"), and the Agent were parties to the Amended and Restated Revolving Credit and Reimbursement Agreement, dated as of January 15, 1998 (as amended, the "Credit Agreement");

IN WITNESS WHEREOF, the Agent has caused this Release to be duly executed as of the day and year first written above.


