## ASSIGNMENT OF NAMES, LOGOS, DESIGNS AND TRADEMARKS

This Agreement is made this 1st day of June, 2000, at Los Angeles, California by and between Paris Blues, Inc., a California corporation ("Assignor") and PBT Company, L.L.C., a California limited liability company ("Assignee").

### RECITALS

A. Assignor is, and has been, the owner of all proprietary rights to the names, logos designs and trademarks identified as or associated with:

"Paris Blues", "Paris Blues (Stylized)", "Parisblues.com", "Paris Blues Club"  
"Luna Blue", "Luna Blue Design", "Quant", "Quant Hombre", "Quant Jeans",  
"Quant Femme", "Snake and Dagger Design", "Snake Design", "JQ" and "JQ  
(Stylized)".

Some of said names, logos, designs and trademarks have been registered in various governmental offices throughout the United States and worldwide including, but not limited to, those registrations shown on Exhibit "1" attached hereto and incorporated herein by reference. All of the names, logos, designs and trademarks referenced above in this paragraph, wherever and whenever registered, along with common law rights to said names, logos, designs and trademarks, are hereinafter referred to collectively as the "Trademark"; and

B. As part of Assignor's restructuring, Assignor is desirous of transferring to Assignee the rights to the sole, exclusive and unconditional use, registration and ownership of the Trademark.

C. As part of Assignor's restructuring, Assignee is desirous of acquiring the rights to the sole, exclusive and unconditional use and ownership of the Trademark; and

NOW, THEREFORE, for valuable consideration, receipt of which is hereby acknowledged, the parties hereto agree to the following terms:

### AGREEMENT

1. The Recitals set forth above are incorporated herein by reference.

2. Assignor hereby grants, sells, conveys, assigns and transfers to Assignee the rights to the sole, exclusive and unconditional use, registration and ownership of the Trademark together with that part of the goodwill of Assignor's business connected with the use of, and symbolized by, the Trademark.

3. Assignor hereby covenants, warrants and represents to Assignee that Assignor is the sole owner of and has the exclusive right to use the Trademark free and clear of any liens, encumbrances, licenses or claims of any nature except as otherwise disclosed by Assignor to Assignee, and Assignor has made no agreement with respect to the Trademark that is in conflict with this Agreement.

4. This Assignment is effective as of June 1, 2000.

5. This Agreement has been entered into in the State of California and shall be construed and interpreted under the laws of the State of California.

6. In the event that any legal action is brought to enforce or interpret any of the terms of this Agreement, the prevailing party shall be entitled to recover its actual attorney's fees and costs.

WHEREFORE, the parties have executed this Agreement as of the date first set forth above.

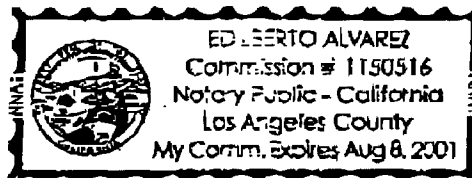
