RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Agreement") is made as of the 27th day of April, 2001 between Integrity Incorporated, a Delaware corporation (the "Assignor"), and Bank Austria Creditanstalt Corporate Finance, Inc., f/k/a Creditanstalt Corporate Finance, Inc., a Delaware corporation (the "Assignee").

WHEREAS, in order to induce the Assignee to make loans and extend credit to the Assignor, the Assignor agreed to assign and did assign to the Assignee a security interest in and to the Assignor's trademarks and service marks (the "Marks") in the Conditional Assignment and Trademark Security Agreement dated as of August 2, 1996 (the "Trademark Security Agreement"), recorded in the U.S. Patent and Trademark Office at Reel 1550/Frame 0130 and Reel 1574/Frame 0690; and

WHEREAS, pursuant to that certain Trademark Security Agreement, Assignee is required to release its lien on and security interest in the Marks;

NOW, THEREFORE, in consideration of the premises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee does hereby release, without recourse, its security interest in and to the Marks and the U.S. registrations of and for the Marks as set forth on the attached Exhibit A. Assignee does hereby further release and forever discharge all right, title and interest in and to all liens in and to the Marks and the U.S. registrations therefor, including without limitation the liens created by the Trademark Security Agreement, and does expressly release any and all rights that the undersigned may now or hereafter have to establish or enforce said lien or liens. Nothing herein shall be deemed to evidence or constitute an acknowledgment by Assignee of the satisfaction of any indebtedness and other obligations heretofore secured by the Trademark Security Agreement.

Assignee hereby agrees to execute such further instruments and documents and perform such further acts as Assignor may deem necessary to secure to Assignor the rights herein conveyed.
