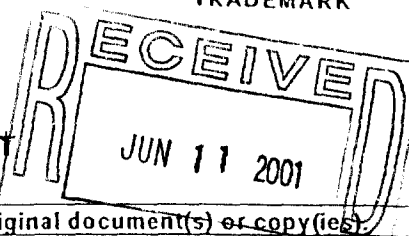



## TRADEMARK ASSIGNMENT

**WHEREAS, SMITHKLINE BEECHAM CORPORATION**, a corporation of the Commonwealth of Pennsylvania, with an address of One Franklin Plaza, Philadelphia, Pennsylvania 19101 ("Assignor") is, either itself or through its direct or indirect subsidiaries and affiliates, the owner of the entire right, title and interest in and to the trademarks **GASTROCCULT**, **HAEMOCCULT**, **HEMOCCULT**, **HEMOCCULT II**, **DETECT-ASE** and **PERFORMANCE MONITORS** (hereinafter the "Trademarks") in the countries identified in the attached Schedule, the goodwill of the business symbolized thereby and the applications or registrations relating to the Trademark in those countries; and

Assignor does hereby sell, assign, transfer and quitclaim unto Assignee the entire right, title and interest of Assignor in and to the Trademarks in the countries identified on the Schedule together with the goodwill of the business symbolized thereby and the applications or registrations relating to the Trademarks in those countries.

2. Assignor covenants and agrees that it will, upon request, execute (including appropriate notarization and legalization) and deliver, or cause to be executed or delivered, any and all documents provided by Assignee that may be necessary or desirable to transfer to Assignee, its successors or other legal representative, all of Assignor's right, title and interest to the Trademarks in the countries listed in the Schedule and all applications or registrations for the Trademarks in those countries.



5. For purposes of this Agreement, "subsidiaries and affiliates" means any business entity controlled by, controlling or under common control with a party hereto.


