

ASSIGNMENT AGREEMENT

ASSIGNMENT AGREEMENT made as of the first day of August 2000, by and between Van Cleef & Arpels, Inc., a company organized under the laws of the State of New York, having its office at 744 Fifth Avenue, New York, NY 10151 on its behalf and as agent for, and on behalf of, the entities listed on Schedule A (each of these entities and Van Cleef & Arpels, Inc., an "Assignor" and collectively, the "Assignors") and Van Cleef & Arpels Logistics SA, a company organized under the laws of Switzerland with offices at route de Chamdolan 8, CH-1752 Villards-sur-Glâne. (hereinafter referred to as the "Assignee").

WHEREAS, each Assignor is the owner of certain Trademarks as set forth in Schedule B, attached hereto and made a part hereof, and possibly of others, together with the goodwill of the business symbolized thereby, which Trademarks with respect to each Assignor are hereinafter referred to collectively as "the said Trademarks;"

WHEREAS, each Assignor is the owner of other intellectual property rights, including without limitation, patents, design patents, designs, domain names (as set forth in Schedule C), copyrights (as set forth in Schedule D), trade dress, and trade names, together with the goodwill of the business symbolized by such trade dress and trade names, which rights with respect to each Assignor are hereinafter referred to collectively as "the said Intellectual Property;" and

WHEREAS, each Assignor has agreed to assign to Assignee all right, title and interest in and to the said Trademarks and the said Intellectual Property, together with all appurtenant goodwill, rights thereto, and benefits thereof, and Assignee has agreed to accept such Assignment (as defined below), all on the terms and conditions as are more fully set forth hereunder.

NOW THEREFORE, for good and valuable consideration, the receipt of which is duly acknowledged, it is hereby agreed as follows:

- 1) Each Assignor hereby assigns to Assignee all right, title and interest in and to the said Trademarks and the said Intellectual Property, including, without limitation, all registrations and pending applications in relation thereto, in all jurisdictions and countries of the world, together with the goodwill of the business in which the said Trademarks and the said Intellectual Property are and/or have been used, and the goodwill appurtenant to, associated with, and symbolized by the use of the said Trademarks and the said Intellectual Property,

and all rights which such Assignor may have acquired through the use and/or the registration of the said Trademarks and the said Intellectual Property by or on behalf of such Assignor and/or its predecessors and all rights relating to or arising from the use of the said Trademarks and the said Intellectual Property, and/or all rights in law and/or equity in relation thereto, all rights to claim legal, equitable and/or administrative relief in respect of the infringement, imitation, dilution, or other unauthorized use of the said Trademarks and the said Intellectual Property, and any and all other benefits and advantages in any manner accruing to such Assignor and/or its predecessors arising from or relating to the said Trademarks and the said Intellectual Property, and the use and ownership thereof (the "Assignment").


- 2) To the extent that each Assignor shall be entitled to the benefit of any of the foregoing rights subject to the perfection of a written conveyance by any other person or entity, each Assignor undertakes to use its best efforts to obtain and perfect such written conveyance in favor of, and to the benefit of, the Assignee.
- 3) Each Assignor further undertakes, without additional consideration, to execute, and/or to procure the execution and delivery of, all assignment deeds, transfer documents, acquittances, acknowledgments and other instruments of transfer, as well as any other documents necessary or appropriate to effectuate the Assignment, and each Assignor undertakes to provide and/or arrange for the provision of, all information and documentation as may be necessary to fulfill its obligations herein.
- 4) Each Assignor further undertakes to comply with the relevant requirements of any jurisdiction pertaining to the Assignment herein, and each Assignor specifically undertakes to execute, and/or to procure the execution of, and the delivery to, Assignee of such authorizations, Powers of Attorney and related instruments of transfer, as well as other lawful papers, which may be required to effectuate the Assignment herein, and Assignor undertakes, with respect to the said Trademarks and the said Intellectual Property, to do all things as may be required, or be deemed appropriate, so as to enable due recordal of the Assignment to be effected and completed in favor of Assignee in all jurisdictions to which this Assignment relates. In addition, each Assignor undertakes to execute, and/or have executed, any and all documentation necessary to confirm and/or to maintain in full force and effect any license recordals, authorized use recordals and/or related recordations, wherever necessary or appropriate to

effectuate in full the Assignment herein. All recordal costs and expenses shall be borne by Assignee.

- 5) Additionally, each Assignor assigns, transfers and conveys to Assignee exclusively all rights to institute or maintain legal proceedings, or to secure legal and/or administrative relief, in respect of any infringement of, or other unauthorized use in relation to, the said Trademarks and the said Intellectual Property, which may have arisen or accrued prior to the effective date of this Assignment.
- 6) Each Assignor furthermore appoints and constitutes Assignee as its attorney-in-fact, with full power of substitution, for and on behalf of such Assignor, respectively, in relation to any purpose, matter, or action necessary or appropriate to effectuate and/or confirm the Assignment herein.
- 7) It is hereby agreed and acknowledged that this Assignment shall immediately become effective, so that Assignee shall be immediately vested with ownership of the said Trademarks and the said Intellectual Property and of any other properties and benefits conveyed herein.


