TRADEMARK AND TRADE NAME ASSIGNMENT

THIS TRADE MARK AND TRADE NAME ASSIGNMENT (the "Assignment") is made as of this 31st day of May, 2001, by BAYLINER MARINE CORPORATION, a Delaware corporation ("Bayliner"), with its principal office at P.O. Box 9029 Everett, Washington 98206, transferring and assigning the rights and interests identified below to ROBALO ACQUISITION COMPANY, LLC, a Georgia limited liability company ("RAC").

WHEREAS, Bayliner is, among other things, engaged in the manufacture and sale of a line of outboard fishing boats and related products under the brand name Robalo (the "Robalo Business");

WHEREAS, Bayliner and RAC are parties to a certain Asset Purchase Agreement (the "Asset Purchase Agreement"), dated of even date herewith, pursuant to which, among other things, Bayliner has agreed to sell, and RAC has agreed to purchase, certain Assets (as defined in the Asset Purchase Agreement) including, without limitation, the United States Trademark Registration, Serial Number 72456285, for the trademark "Robalo" (the "Mark") and the goodwill of the Robalo Business associated with the Mark; and

WHEREAS, RAC wishes to acquire Bayliner's entire right, title and interest in and to the Mark, together with the goodwill of the Robalo Business associated with the Mark;


NOW THEREFORE, for the good and valuable consideration set forth in the identified Asset Purchase Agreement, the receipt of which is hereby acknowledged, Bayliner does hereby sell and assign to RAC all the right, title and interest Bayliner has or may have in the Mark, together with the goodwill of the Robalo Business associated with the Mark.

Bayliner will assist in obtaining or providing any further documents which may be required to confirm chain of title thereto.
