TRADEMARK AND SERVICE MARK ASSIGNMENT

THIS TRADEMARK AND SERVICE MARK ASSIGNMENT is made this 1st day of May, 2001, by PVA-EPVA, Inc., a New Hampshire corporation ("Assignor").


WHEREAS, Assignor has entered into an Exclusive License Agreement, dated April 18, 2000 (the "Agreement"), with Brick Mill Studios, Inc., a New Hampshire corporation ("Assignee"), which provides, in part, that the Assignee shall have the option to purchase all common law trademarks, service marks and United States trademark and service mark registrations, listed on Schedule A attached hereto, and the goodwill symbolized and associated with the marks (collectively referred to herein as the "Marks"); and

WHEREAS, Assignee has exercised its option to purchase the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, its successors, legal representatives and assigns, all of Assignor's right, title and interest in and to the Marks together with the goodwill associated with the Marks and all registrations and/or applications thereof (including, without limitation, all proceeds thereof and the rights to sue for past, present and future infringements), the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale and assignment not been made.

Assignor hereby requests that the Commissioner of Patents and Trademarks record Assignee as assignee of the United States trademark and service mark registrations listed on Schedule A for the sole use and enjoyment of Assignee, its successors, legal representatives and assigns.
