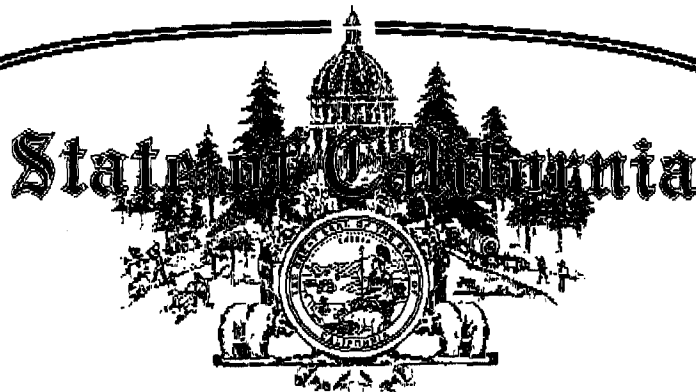

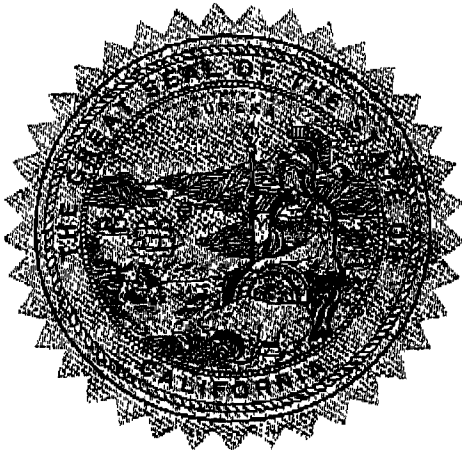

TWO: Article I of the Amended and Restated Articles of Incorporation of this corporation is amended to read as follows:

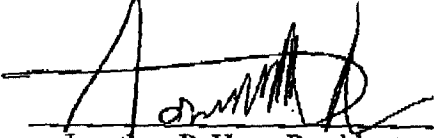
The name of this corporation is Consilient, Inc.
