RELEASE OF SECURITY INTEREST IN TRADEMARKS

Reference is hereby made to the agreement dated September 30, 1999 (the "Agreement") pursuant to which **Doehler-Jarvis, Inc.**, a Delaware corporation, ("Doehler"), granted to General Electric Capital Corporation, a New York Corporation, in its capacity as agent for certain Lenders (as defined in the Agreement) ("GECC") a continuing security interest in all of Doehler's right, title and interest in, to and under the following, whether presently existing or hereafter acquired (collectively the "Trademark Collateral"):


- (a) all of its Trademarks and Trademark Licenses to which it is a party including those referred to on Schedule A hereto;
- (b) all reissues, continuations or extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
- (d) all products and proceeds of the foregoing, including, without limitation, any claim by Doehler against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

The Agreement was recorded in the United States Patent and Trademark Office on October 19, 1999, at Reel 001977, Frame 0032.

GECC hereby acknowledges and agrees that notwithstanding the foregoing grant of a continuing security interest in all of Doehler's right, title and interest in, to and under the Trademark Collateral, together with the registration in the United States Patent and Trademark Office of the Agreement evidencing this grant (the "Security Interest"), GECC hereby releases and terminates the Security Interest.




