

ASSIGNMENT OF REGISTERED TRADEMARK

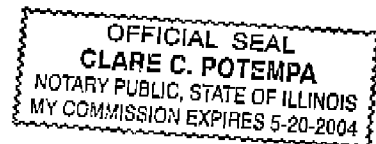
