WHEREAS, the estate of KML was probated in the courts of Dade County, FL and the probate of the estate has been finalized;



WHEREAS, KML was the owner of Federal Trademark Registration 822,801 which was renewed for a 20-year period on January 24, 1987 for the trademark EXPRESS for masonry drills, mechanics hand tools, carpenter's tools, masonry tools and small handtools;

WHEREAS, BL and MICASA are desirous of executing a formal assignment agreement of the trademark rights KML transferred to MICASA for good and valuable consideration;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, said Bennett Last does hereby assign unto the said Micasa Trading Corporation, d/b/a Impex Systems Group, Inc., all right, title and interest in and to the said mark, together with the good will of the business symbolized

by the mark, and the above-identified United States registration of said mark.
