## INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT, dated as of April 1, 2001, by and between Yamanouchi Consumer Inc., a Delaware corporation ("Assignor") and Shaklee Corporation, a Delaware corporation ("Assignee"), (and, together with Assignor, the "Parties" and each, individually, a "Party").

WHEREAS, pursuant to the Restructuring Agreement of April 1, 2001 (the "Restructuring Agreement"), the parties desire to transfer to Assignee on or after April 1, 2001, as provided for in the Restructuring Agreement, many of the commercial business operations which have historically been conducted by Assignor, initially as its Shaklee Companies division and subsequently as its Shaklee Corporation division (the "Shaklee Companies Division"); and

WHEREAS, Assignor owns, and has adopted for use in its Shaklee Companies Division: (a) the registered trademarks, service marks and pending trademark applications listed on the attached Schedule A, together with the registered Internet domain names listed on the attached Schedule B, and all other trademarks, trade names, trade dress and service marks, whether registered or unregistered that are associated with the Shaklee Companies Division, together with the registrations and applications therefor (collectively, the "Marks"); (b) the registered and unregistered copyrights relating to or arising out of the Shaklee Companies Division including those registered copyrights listed on the attached Schedule C (the "Copyrights"); (c) all trade secrets and know-how, and any related documentation, drawings, blueprints, designs, technical and quality specifications and protocols, quality assurance and control procedures, manuals and other technical information associated with the Shaklee Companies Division (the "Technical Expertise"); and (d) all patents, pending patent applications and the right to file patent applications relating to or arising out of the Shaklee Companies Division including those patents listed on the attached Schedule D (the "Patents"), (collectively the Marks, Copyrights, Technical Expertise, and Patents are hereinafter referred to as the "Intellectual Property"); and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in, to and under the Intellectual Property as of April 1, 2001.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor hereby conveys, transfers and assigns to Assignee, all right, title and interest in and to the Intellectual Property, together with all rights of action accrued, accruing and to accrue under and by virtue hereof, including the right to sue or otherwise recover for past infringement and receive all damages, payments, costs and fees associated therewith. The assignment of the Marks granted herein includes the goodwill of the business symbolized by the Marks. The assignment of the Copyrights granted



herein includes the right to secure renewals and extensions of such Copyrights throughout the world, for the full term of said Copyrights and any renewal extensions of same that is or may be granted throughout the world in the Copyrights, and any embodiments necessary for the exercise of such Copyrights or derivative works thereof. The assignment of the Patents granted herein includes the right to secure renewals and extensions of such Patents throughout the world, for the full term of said Patents and any extensions of same that is or may be granted throughout the world in the Patents and anything else that is required to enforce, maintain and defend the Assignee's Patents including the payment of maintenance fees.

2. Assignor hereby agrees to execute all such documents as may be required to transfer the Intellectual Property and, when applicable, to record the transfer of the Intellectual Property.

3. This Intellectual Property Assignment constitutes the entire understanding and agreement between the parties and supersedes all prior proposals, agreements and representations between them, whether written or oral, with respect to the subject matter hereof.
