PARTIAL RELEASE OF SECURITY INTEREST

THIS PARTIAL RELEASE OF SECURITY INTEREST ("this Partial Release") is made as of the ~~6th~~ day of June, 2001, by and between FLEET PRECIOUS METALS INC. and FLEET NATIONAL BANK (jointly and severally, "Lenders") and SEMI-ALLOYS COMPANY, A LIMITED LIABILITY COMPANY, a Wyoming limited liability company with its principal offices at 888 South Columbus Avenue, Mount Vernon, New York 10550 (the "Company").

WITNESSETH:

WHEREAS, pursuant to a certain Collateral Assignment of Trademarks dated as of September 26, 1991 and recorded with the U.S. Patent and Trademark Office (the "Assignment"), the Company assigned and transferred and granted a lien and security interest in certain trademarks and service marks to the Lenders as security for performance by the Company of its obligations under certain agreements; and

WHEREAS, each of the Lenders has agreed to release its security interest in and lien upon the trademark entitled "COMBOS" to the Company;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, the Lenders and the Company hereby agree as follows:

Except as amended hereby, the Assignment shall remain in full force and effect and is in all respects hereby ratified and affirmed and all security interests, liens and assignments granted by the Company to the Lenders therein shall continue to secure the obligations of the Company to the Lenders.

This Partial Release is and shall be deemed to be a contract entered into and made pursuant to the laws of the State of Rhode Island and shall in all respects be governed, construed, applied and enforced in accordance with the laws of the State of Rhode Island, without reference to its conflicts of laws principles.
