

Attachment A

Corporate Restructure

Initially, NextMedia Group, LLC, a Delaware limited liability company (“NMG”), acquired the assets of The JET Broadcasting Company, Inc., in connection with the acquisition of radio stations WFGO(FM) and WAGT(FM).

Subsequently, NextMedia Group II, Inc., a Delaware corporation (“NMGII”), assumed the rights and obligations of NMG with respect to the above-mentioned acquisition, pursuant to a conversion under Section 265 of Delaware General Corporation Law.

Thereafter, NMGII was merged into and with NextMedia Operating, Inc., a Delaware corporation, with NextMedia Operating, Inc. being the surviving entity.
