

RELEASE AND REASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, The William Carter Company, a Massachusetts corporation (successor to TWCC Acquisition Corp. by merger) (the "Company"), owns: (a) the registered trademarks described in the attached Schedule A (the "Marks"), for which a recording is filed in the United States Patent and Trademark Office under the number set forth in the attached Schedule A; (b) the patents described in the attached Schedule B (the "Patents"), for which recordings are filed in the United States Patent and Trademark Office under the number set forth in the attached Schedule B; and (c) the copyrights described in the attached Schedule C (the "Copyrights"), for which recordings are filed in the Copyright Office of the United States under the number set forth in the attached Schedule C (the Marks, Patents and Copyrights together comprising the "Intellectual Property"); and

WHEREAS, pursuant to those certain:

(a) Trademark Security Agreement dated as of October 30, 1996 (the "Trademark Agreement"), recorded in the Assignment Branch, United States Patent and Trademark Office, on November 27, 1996, located on Reel 1573, Frame 0423;

(b) Patent Security Agreement dated as of October 30, 1996 (the "Patent Agreement"), recorded in the Assignment Branch, United States Patent and Trademark Office, on November 27, 1996, located on Reel 008251, Frame 0516; and

(c) Copyright Security Agreement dated as of October 30, 1996 (the "Copyright Agreement"), recorded in the Copyright Office of the United States, on November 29, 1996, located at Volume 3316, Pages 77-88;

the Company granted a security interest in the Marks, Patents and Copyrights, respectively, to The Chase Manhattan Bank, as Administrative Agent (the "Agent") for a group of lenders, to secure performance by the Company of its obligations to such lenders;

WHEREAS, the Company has paid and performed in full its obligations to such lenders and terminated all further obligations of such lenders to extend credit to the Company and its affiliates;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby terminates all of its right, title and interest in, to and under the Intellectual Property and reassigns and reconveys to the Company the Intellectual Property including, without limitation: (a) with respect to the Marks, all the good will of the business symbolized by the Marks, together with the application, registration and recordings in the United States Patent and Trademark Office, and all reissues, extensions or renewals thereof; (b) with respect to the Patents, the application, issued patent and recordings in the United States Patent and Trademark Office, and all patents based upon or claiming priority therefrom; and (c) with respect to the Copyrights, the application, registration and recordings in the Copyright Office of the United States; and the right to sue and recover damages for future infringements thereof and to stand in the place of the Agent in all matters related thereto.

The parties hereto have caused this Release and Reassignment of Intellectual Property to be executed this ____ day of August, 2001.
