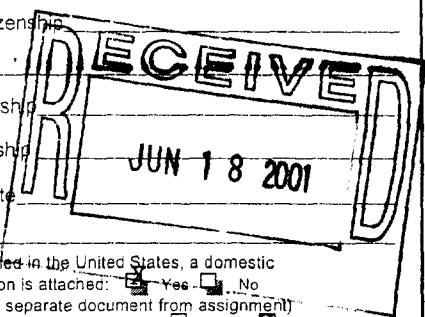



- (B) WCI has agreed, to sell, assign and transfer the Marks to Lavatec.


