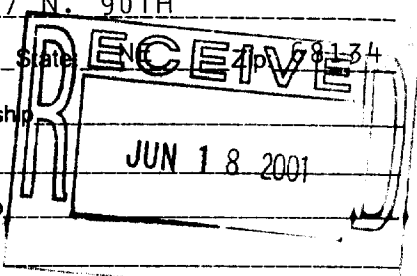

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION OF
