WHEREAS, EXCELSIOR PROCESS & ENGRAVING, INC. (hereinafter "EXCELSIOR"), a corporation organized under the laws of Delaware, previously having a principal place of business in North Adams, MA, merged on December 31, 1998, with CRANE & CO., INC.
