ASSIGNMENT

WHEREAS, Borg-Warner Chemicals, Inc. ("BWC-NEW") is a Delaware corporation having its principal office at UNB Square, 5th and Avery Streets, Parkersburg, WV, 26102 and was formerly registered as BW-ABS Corporation; and

WHEREAS, BWC-NEW acquired, by mesne assignment, all right, title and interest in and to registered and unregistered trademarks, service marks, slogans and other product and service designations adopted and/or used by Borg-Warner Chemicals, Inc. ("BWC-OLD"), in the conduct of BWC-OLD's plastics business (hereinafter collectively referred to as the "Marks"); and

WHEREAS, the General Electric Company ("GE"), a New York corporation having its principal place of business at 3135 Easton Turnpike, Fairfield, Connecticut, 06431, acquired all of the outstanding common stock of BWC-NEW and wishes to have the Marks assigned to it.

NOW THEREFORE, for value received, BWC-NEW hereby sells, assigns and transfers to GE, effective as of November 1, 1988, all of its right, title and interest throughout the world in and to the Marks, including the registrations and applications for registration therefor, as listed in Exhibit A, together with the good will of the business symbolized thereby.

If any trademarks, service marks, slogans, or other product or service designations are hereafter identified which should have been listed in Exhibit A, but were not so listed, BWC-NEW hereby agrees to supplement said Schedule at such time by adding any such designations thereto effective as of November 1, 1988.

BWC-NEW hereby authorizes any officer of GE and the General Patent Counsel of GE, and each of them, at any time, and from time to time, to execute and deliver all such proper assignments and other instruments and to make or cause to be taken all such further action as GE may deem necessary or desirable, in the name of BWC-NEW, in order to vest, perfect or confirm in GE title to and possession of all of the Marks sold, assigned, and transferred to GE by this Assignment, and to conduct all proceedings pertaining thereto before the governmental agencies and courts serving any country or region of the world.

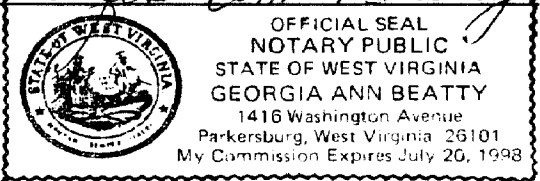
