ASSIGNMENT OF FEDERAL INTENT-TO-USE APPLICATION

WHEREAS, Mitchell International, Inc. ("Assignor"), a Delaware corporation, having a place of business at 9889 Willow Creek Road, San Diego, CA 92131, intended to use the mark INTEGRICLAIM in commerce and filed an application on May 14, 1999, now assigned Serial No. 75/706,843, with the United States Patent and Trademark Office under Section 1(b) of the Trademark Act, indicating that intention, and had filed a Statement of Use under Section 1(d) of the Trademark Act on April 11, 2001, and

WHEREAS, E.H. Boeckh Company, LLC ("Assignee"), a Delaware limited liability company, having a place of business at 228 South Calhoun Road, New Berlin, WI, was desirous of acquiring said trademark and the pending intent-to-use application therefor;

WHEREAS, Assignor and Assignee entered into an Asset Purchase Agreement dated February 9, 2001 providing for the transfer of the trademark in the aforementioned application to Assignee; and substantially all of the business or the portion thereof to which the mark pertains, as required by 15 U.S.C. Section 1060; and

WHEREAS, Assignor and Assignee desire to have a recordable document evidencing such transfer;

NOW, THEREFOR, in consideration of the foregoing recitals and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby confirms that it previously transferred to Assignee all right, title and interest in the United States in and to said trademark and said application together with all common law rights and the goodwill of the business symbolized by said trademark and registration thereof.

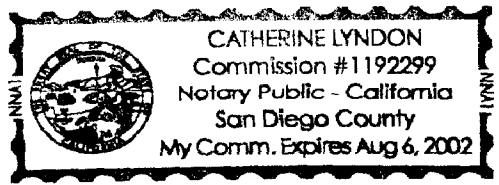
