

TRADEMARK ASSIGNMENT

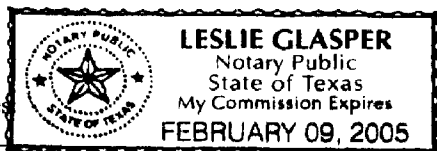
