CERTIFICATE OF AMENDMENT TO THE
RESTATED CERTIFICATE OF INCORPORATION
OF
GENSIA SICOR INC.

Gensia Sicor Inc., a corporation organized and existing under the laws of the State of Delaware, hereby certifies as follows:

FIRST: The name of the corporation is Gensia Sicor Inc. and shall hereby be changed to SICOR Inc.

SECOND: The date of filing of its original Certificate of Incorporation with the Secretary of State of Delaware was November 17, 1986. The corporation was originally incorporated under the name Gensia Pharmaceuticals, Inc.

THIRD: At a meeting of the Board of Directors of Gensia Sicor Inc., resolutions were duly adopted providing that it was advisable and in the best interests of the corporation that Article I of the Restated Certificate of Incorporation of Gensia Sicor Inc., shall be amended to read in its entirety as follows:

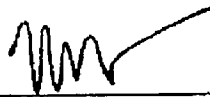
"ARTICLE I
