Upon written request from the Assignee and without further compensation, Assignor shall execute or cause to be executed any and all documents and instruments necessary or desirable to effectuate the intention of paragraph (1.) above, as may be required by Assignee to confirm and secure formally the assignment granted to Assignee pursuant to this Assignment.
