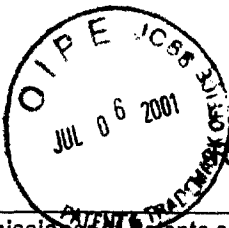



OFFICIAL CONFIRMATION

Following today's inspection of the Commercial Register at the Provincial Court of Klagenfurt, I herewith confirm pursuant to section 89 b of the Notarial Code as follows:-----

- a) The company **„G.D. Anker“ Gebirgs-Dübel-Anker Gesellschaft m.b.H.** with registered seat in Millstadt, Commercial Register No. HRB 92, Spittal/Drau, was founded by shareholder's agreement of February 16, 1965.-----
- b) By resolution of the shareholders' meeting of September 28 (twenty-eight), 1989 (one thousand nine hundred eighty-nine), the business operation of **„G.D. Anker“ Gebirgs-Dübel-Anker Gesellschaft m.b.H. & Co. KG**, which had existed since 1965 (one thousand nine hundred sixty-five), was contributed to **„G.D. Anker“ Gebirgs-Dübel-Anker Gesellschaft m.b.H.** on the basis of the contribution balance sheet as at December 31 (thirty-one) 1988 (one thousand nine hundred eighty-eight) on the contribution reference date and pursuant to the contribution agreement of September 28 (twenty-eight), 1989 (one thousand nine hundred eighty-nine), in order to continue this business operation and to make use of the benefits of Art. III of the Structural Improvement Act regarding taxes and fiscal charges. The limited commercial partnership was dissolved on account of this contribution and it was mutually agreed not to liquidate it. **„G.D. Anker“ Gebirgs-Dübel-Anker Gesellschaft m.b.H. & Co. KG** was registered under HRA 185/Spittal/Drau.
