ASSIGNMENT

This Assignment is made between Thin Planet, Inc., with an address at 30210 Rancho Viejo Road, Suite D, San Juan Capistrano, California 92675 ("Assignor"), and internet.com Corporation, a corporation of the State of Delaware with offices at 23 Old Kings Highway South, Darien, Connecticut 06820 ("Assignee").

Assignor hereby agrees to execute all papers and to perform all other proper acts requested by Assignee or its successors or assigns to secure to Assignee or its successors or assigns the rights hereby transferred.
