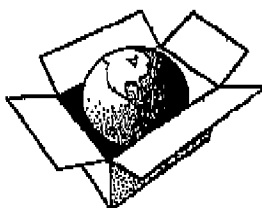

and the United States application therefore, U.S. Ser. No. 76/227,394 (the "Mark"); and


WHEREAS, Assignee is desirous of acquiring rights to the Mark;
