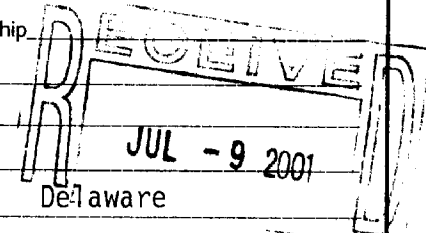




**TERMINATION AND RELEASE OF

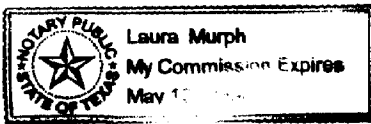
