(TRADEMARKS)

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby further grant to Assignee a security interest in, and mortgage on, the Collateral to secure the prompt payment of the Secured Obligations.



SUBORDINATION AGREEMENT AND DESIGNATION OF LIEN PRIORITY

8th This Subordination Agreement and Designation of Lien Priority ("Agreement") dated the day of June, 2001, is by and between PINNACLE BRANDS, INC., a Delaware corporation, together with certain of its direct and indirect subsidiaries and divisions, specifically GSAC HOLDINGS, INC., PINNACLE TRADING CARD COMPANY, DONRUSS TRADING CARD COMPANY, MLM ACQUISITIONS CORP. and FLAPCO, INC. (respectively and collectively, "Pinnacle"), WELLS FARGO BANK, N.A. ("Agent") and The Frost National Bank ("Frost").

RECITALS

WHEREAS, PLAYOFF CORPORATION, a Texas corporation, is indebted to Pinnacle pursuant to a certain Asset Purchase Agreement dated November 3, 1998, between Playoff Corporation and Pinnacle (the "APA");

WHEREAS, pursuant to a certain Security Agreement and Mortgage-Trademark and Patents dated November 25, 1998, Pinnacle has a first and prior lien and security interest in all of the "Trademarks" conveyed to Playoff Corporation by Pinnacle pursuant to the APA, said Trademarks being listed on Exhibit A attached hereto and incorporated herein by reference;

WHEREAS, Agent is administrative agent for all "First Tier Lenders" who are secured by the proceeds of the sale from Pinnacle to Playoff Corporation as contemplated in the APA and a certain "ORDER (A) AUTHORIZING AND APPROVING ASSET PURCHASE AGREEMENT WITH PLAYOFF CORPORATION; (B) AUTHORIZING THE SALE OF SUBSTANTIALLY ALL OF THE DEBTORS' SPORTS TRADING CARDS ASSETS, FREE AND CLEAR OF ALL LIENS AND ENCUMBRANCES, PURSUANT TO THE TERMS OF ASSET PURCHASE AGREEMENT; AND (C) AUTHORIZING THE DEBTOR TO CONSUMMATE ALL RELATED TRANSACTIONS entered in Pinnacle's Jointly Administered Chapter 11 Bankruptcy Case, No. 98-1716 (MFW), United States Bankruptcy Court for the District of Delaware;

WHEREAS, Frost intends to make a revolving line of credit loan to DONRUSS PLAYOFF, L.P., a Delaware limited partnership and Playoff Corporation (respectively and collectively, "Borrower") for Borrower's use and benefit (the "Loan"); and

WHEREAS, Frost will not approve and make the Loan without a first or prior lien and security interest on all of Borrower's intellectual property and other rights of whatever nature, including, without limitation, goodwill, relating to the Trademarks (collectively, the "Collateral"); and

WHEREAS, Pinnacle and Agent agree to subordinate and by their execution hereof do hereby subordinate the existing prior lien and security interest in and to the Collateral.

AGREEMENT

For and in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Pinnacle, Agent and Frost hereby agree as follows:

1. SUBORDINATION. Pinnacle and Agent hereby agree to subordinate, make second, junior and inferior, their prior lien and security interest, and do hereby subordinate, make second, junior and inferior, the prior lien and security interest in the Collateral.
2. ACKNOWLEDGEMENT OF PRIORITY OF LIENS ON COLLATERAL. Pinnacle and Agent hereby agree and acknowledge that as a result of the subordination, Frost shall have a prior lien and security interest in the Collateral.
3. CROSS DEFAULT. In the event of a default by Borrower, upon the Loan, or the indebtedness of Borrower to Pinnacle/Agent, Borrower and/or Pinnacle/Agent may at their option, respectively, treat the default as a default under their respective debt instruments and agreements, and each may avail itself of any of the rights and remedies contained in their respective debt instruments and agreements, or available at law or in equity, including but not limited to the acceleration of the indebtedness evidenced thereby and foreclosure upon any of the Collateral.
4. NOTICE. In the event of a default requiring notice to Borrower, Frost and Pinnacle/Agent shall each use their best efforts to simultaneously notify each other, by certified mail, return receipt requested, at the addresses stated below.
5. FURTHER ASSURANCES. The parties hereto agree that each will, at its expense and at any time and from time to time, promptly execute and deliver all further instruments and documents and take all further action that may be necessary or desirable, in order to effectuate the agreements set forth herein.
6. CONFLICT WITH EXISTING AGREEMENTS. To the extent this Agreement conflicts with the provisions of any security agreement, financing statements or any other agreement or instrument, this Agreement shall prevail.
7. AMENDMENTS, ETC. No amendment or waiver of any provision of this agreement nor consent to any departure by any party hereto from any of its provisions shall in any event be effective unless the same shall be in writing and signed by the parties hereto.
8. ADDRESS FOR NOTICES. All notices and other communications provided for hereunder shall be in writing and shall be mailed or delivered to the addressee party at the address specified below. All such notices and other communications shall, when mailed or delivered, be effective when deposited in the mail or delivered to the address, as the case may be, addressed as aforesaid.

In addition, this Agreement may be executed via facsimile and such facsimile shall constitute an original copy of this Agreement.
