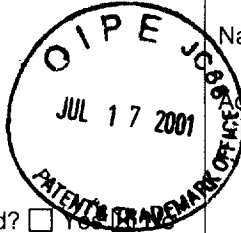

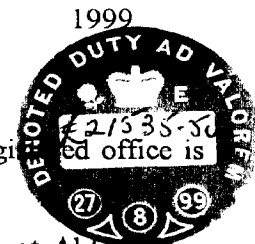

ASSIGNMENT OF TRADE MARKS

THIS ASSIGNMENT is made the 9th day of June 1999



BETWEEN:

- (1) **WEYRAD ELECTRONICS LIMITED** (Company No. 3136654) whose registered office is at Lynch Lane, Weymouth, Dorset DT4 9DG ("the Assignor"); and
- (2) **CHLORIDE GROUP PLC** (Company No. 35389) whose registered office is at Abford House, 15 Wilton Road, London SW1V 1LT ("the Assignee")

RECITALS

- (A) The Assignor is the owner and registered proprietor of the trade mark(s) brief details of which are set out in the Schedule hereto ("the Trade Marks").
- (B) The Assignor has agreed to assign to the Assignee all the rights in the Trade Marks, subject to the terms of this Assignment.

In consideration of the sum of one pound (£1.00) now paid by the Assignee to the Assignor (the receipt of which is hereby acknowledged by the Assignor) **IT IS HEREBY AGREED** as follows:-

- 1. The Assignor **HEREBY ASSIGNS** to the Assignee with full title guarantee all the right, title and interest in and to the Trade Marks including the benefit of any use of the Trade Marks and all statutory and common law rights connected therewith and together with the goodwill associated with, attaching to and symbolised by the Trade Marks as well as all the rights of action, powers and benefits belonging to the same, including the right to seek injunctions and to sue for and obtain damages and other relief in respect of any infringement (whether past, present or future) of the Trade Marks **TO HOLD** the same unto the Assignee absolutely.
- 2. The Assignor warrants that:-
 - (a) it is not prevented in any way from making this Assignment;
 - (b) it does not require licences in relation to any intellectual property or other rights belonging to any third party in respect of the Trade Marks.
- 3. The Assignor covenants with the Assignee that it will at its own expense execute all such further assignments, transfers, deeds, documents or other assurances and do all further acts and things at the reasonable cost of the Assignee as the Assignee may require to secure the vesting in the Assignee of the rights assigned to the Assignee hereunder including without limitation to record this Assignment at the Trade Marks Registry or other appropriate authority in the territories in which the Trade Marks are registered and otherwise to give effect to the terms of this Assignment.

4. This Assignment shall be subject to English law and the parties submit to the exclusive jurisdiction of the English Courts.
