**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION**  
(After acceptance of subscription to shares)

Pursuant to the provisions of Title 29, Chapter 3 of the Code of Laws of the District of Columbia, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the corporation is: Andrews Office Supply & Equipment Co., (the "Corporation").

**SECOND:** The Amendment to the Articles of Incorporation, inserted herein, was advised by the directors and adopted by the shareholders on March 15, 2000 in the manner prescribed by the Code of Laws of the District of Columbia.

The Articles of Incorporation of the Corporation are hereby amended by striking in its entirety Article FIRST and by substituting in lieu thereof the following (the "Amendment"):

**FIRST:** The name of the corporation is US Office Products, Mid-Atlantic District, Inc.

**THIRD:** The Amendment received an affirmative vote of the holders of at least two-thirds of the outstanding shares entitled to vote.

**FOURTH:** The manner, if not contained in the Amendment itself, in which any exchange, reclassification, or cancellation of issued shares shall be effected, is as follows:
