

TRADEMARK ASSIGNMENT

This Trademark Assignment, is made and entered into as of the 6th day of September 2001, but effective as of March 7, 2000, by and between Berol Corporation, a Delaware Corporation, with its principal place of business at 29 E. Stephenson St., Freeport, IL 6032 ("Assignor") and Iceberg Enterprises, LLC, a Delaware Limited Liability Company with its principal place of business at 310 Windy Point Drive, Glendale Heights, IL 60139 ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademarks, and the registrations and applications therefore (collectively the "Trademarks"), which have been issued by the United States Patent and Trademark Office or the foreign country of registry as listed on Exhibit A attached hereto.

WHEREAS, Assignor desires to sell, transfer and assign to Assignee all of Assignor's right, title and interest in and to the Trademarks in accordance with the terms of this Trademark Assignment; and

WHEREAS, Assignee is desirous of acquiring all of Assignor's right, title and interest in and to the Trademarks.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby sells, assigns and transfers to Assignee, throughout the United States and throughout the world: (a) all of Assignor's right, title and interest in and to the Trademarks, including all existing and future registrations of such trademarks and all renewals thereof; (b) the good will of Assignor's business in connection with which the Trademarks are used and which is symbolized by said Trademarks; (c) all income, royalties, damages and payments now or hereafter due and/or payable under and with respect to the Trademarks, including, without limitation, payments under all licenses entered into in connection with the Trademarks and all damages and

payments for past and future infringements of the Trademarks; (d) the right to sue for past, present and future infringements of the Trademarks; and (e) all other rights and benefits corresponding to the Trademarks.

2. Assignee hereby accepts the assignment of the Trademarks subject to the terms of this Trademark Assignment.

3. At Assignee's reasonable request and without further consideration, Assignor will execute and deliver such other instruments and take such other action as Assignee may request for the consummation or documentation of the assignment of said Trademarks.

4. Assignor authorizes and requests the Commissioner of Patents and Trademarks to issue all United States Trademark Registrations on the Trademarks referenced herein directly to Assignee of the entire interest.

5. Assignor respectfully requests that the Commissioner of Patents and Trademarks record this Trademark Assignment in the United States Patent and Trademark Office against the file of the applications herein described.
