

WHEREAS, the United States Bankruptcy Court for the Southern District of New York has entered an order confirming the First Amended Joint Plan of Reorganization of The Singer Company N.V. and its Affiliated Debtors and Debtors-in-Possession dated as of June 22, 2000, authorizing and directing Assignor to transfer to Assignee certain of the assets owned by Assignor including, but not limited to, the assets listed on Schedule A attached hereto and the applications and registrations listed in Schedule B hereto (such assets hereinafter referred to as the "Assets");

- (iv) copyrights and copyright registrations and applications including, but not limited to, those applications and registrations set forth on Schedules A and B hereto;

(v) computer programs and other computer software (including CD-ROMs) including source code and object code for the software programs already published, currently being published or proposed to be published including but not limited to, those programs and software set forth on Schedules A and B hereto;




