ASSIGNMENT OF TRADEMARK

WHEREAS, Immunivest Corporation, a Delaware Corporation having a place of business at 1105 North Market St. Suite 1300, Wilmington, DE (“ASSIGNOR”) filed U.S. Trademark Application No. 75/658,693 on March 13, 1999 for registration of “CELLSEARCH” (the “Mark”), on which Registration No. 2,395,028 was granted October 17, 2000.

WHEREAS, Immunicon Corporation, a corporation organized under the laws of the Commonwealth of Pennsylvania, having its principle place of business at 3401 Masons Mill Business Campus, Suite 100, Huntingdon Valley, Pennsylvania 19006. NOW, THEREFORE, in consideration of the amount of One (\$1.00) Dollar, and other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, transfer and set over to said ASSIGNEE all of its right, title and interest in and to said Mark, and the above-identified Registration, including all common law rights together with the goodwill of the business symbolized by the Mark, and including the right to sue and recover for any past infringement, said rights to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use and benefit of its successors, assigns, or other legal representatives as fully and entirely as the same would have been held and enjoyed by said ASSIGNOR if this Assignment and sale had not been made.
