PARTIAL RELEASE AND ASSIGNMENT OF COLLATERAL

1. This Partial Release and Assignment of Collateral (the "Release and Assignment") is made in reference to that certain Amended and Restated Trademark Collateral Security and Pledge Agreement among TransTechnology Corporation ("TTC"), Seeger, TCR, ARM, NORCO, TTEC, TransTechnology Canada and Fleet National Bank, formerly known as BankBoston, N.A., as Administrative Agent, ("Fleet"), dated as of June 30, 1995, amended and restated as of August 31, 1999 (the "Collateral Security Agreement") and recorded with the United States Patent and Trademark Office on November 8, 1999 (Trademark Reel Number 001982 and Frame Number 0669). Capitalized terms not otherwise defined in this Release and Assignment have the meanings given to them in the Collateral Security Agreement.

2. This Release and Assignment certifies that, in consideration of the payment to the Lenders of the purchase price set forth in that certain Asset Sale and Purchase Agreement dated June 29, 2001, by and between TransTechnology Corporation ("TTC") and Breeze Industrial Products Corporation (the "Asset Agreement"), Fleet hereby releases and discharges its continuing security interest in and first priority lien on the Pledged Trademarks as listed on **Annex A** (the "BIP Trademarks").

3. Fleet represents and warrants to the Assignors that it has not exercised its conditional rights pursuant to Section 2.2 of the Collateral Security Agreement.

4. As a result of its execution of this Release and Assignment, Fleet agrees that the BIP Trademarks are no longer subject to the provisions of the Collateral Security Agreement.

5. Each of the parties agrees that this Release and Assignment shall not constitute an Event of Default under the Collateral Security Agreement.

6. At any time, and from time to time, after the execution of this Release and Assignment, Assignors and Fleet shall perform all reasonable acts at TTC's expense (including, without limitation, the use of reasonable steps to enable the Assignors to accomplish assignments, transfers, registrations, permits, approvals and the like relating to the BIP Trademarks) and shall execute, acknowledge and deliver such assignments, transfers, consents and other documents as Assignors or their counsel may reasonably require to evidence the release of its security interests in the BIP Trademarks.

7. This Release and Assignment shall be governed by and be construed in accordance with the domestic laws of the State of Massachusetts without regard to principles of conflicts of law, and shall be binding upon TTC and Fleet and their respective successors and assigns.
