

"The name of the Corporation is: HBC Los Angeles, Inc."


SECOND: That there are 100 shares outstanding, all issued to Hispanic

was duly adopted in accordance with the provisions of the California Corporations Code.



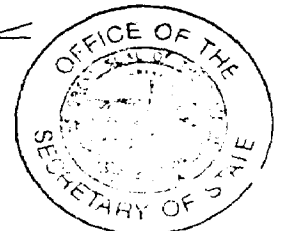
