**FIRST:** That the Board of Directors of CheckFree Corporation, by unanimous written consent in lieu of a meeting, pursuant to Section 141(f) of the General Corporation Law of the State of Delaware duly adopted resolutions setting forth a proposed Amendment to the Certificate of Incorporation of CheckFree Corporation, and declaring said Amendment to be advisable and recommending approval by the stockholders of said Corporation for consideration thereof. The resolution setting forth the proposed Amendment is as follows:

**RESOLVED,** that the Certificate of Incorporation of this Corporation be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:

**FIRST:** The name of the Corporation is CheckFree Services Corporation.

**SECOND:** That in lieu of a meeting and vote of the stockholders, the stockholders of the Corporation by unanimous written consent pursuant to Section 228(a) of the General Corporation Law of the State of Delaware duly adopted the aforesaid Amendments and said Written consent was filed with the Corporation.

**THIRD:** That said Amendment was duly adopted in accordance with the provisions of Section 242 and 228 of the General Corporation Law of the State of Delaware.

**FOURTH:** That the capital of said Corporation shall not be reduced under or by reason of said Amendment.


