## TRADEMARK ASSIGNMENT

This Assignment is made and entered into as of March 29, 2000

By and between:

**AMERICAN CYANAMID COMPANY**, a Maine corporation, whose principal place of business is at 5 Giralda Farms, Madison, New Jersey 07940 (referred to as "the Assignor")

and

**CENTRAL GARDEN & PET COMPANY** a Delaware corporation, whose principal place of business is at 3697 Mount Diablo Boulevard, Suite 310, Lafayette, CA 94549 (referred to as "the Assignee");

WHEREAS, Assignor is the owner of certain trademarks relating to the insecticidal and herbicidal business and the applications for registration and/or registrations granted in respect thereof, all as set forth on the attached Exhibit 1 (referred to as the "Trademarks"); and

WHEREAS, Assignor and Assignee entered into that certain Purchase and Sale Agreement, dated as of March 20, 2000 (the "Purchase Agreement"), pursuant to which Assignor agreed that it will transfer, assign, and deliver to Assignee, and Assignee agreed to acquire, all of Assignor's right, title and interest in and to the Trademarks and the registrations and/or the applications for registration therefor.

NOW IT IS HEREBY AGREED as follows:



In consideration of mutual covenants contained herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Assignor hereby sells, transfers and assigns to Assignee its successors and assigns, Assignor's entire right, title and interest in and to the Trademarks and the registrations and/or applications for registration therefor, and any renewals thereof, together with the goodwill associated with the Trademarks.
2. For a twelve (12) month period from the date hereof, the Assignor shall, to the extent reasonably requested by Assignee execute and deliver such further instruments furnished by Assignee and perform any other reasonable acts that Assignee may require as being necessary for vesting in Assignee the full benefit of all of the rights and premises hereby assigned. Assignee shall reimburse Assignor for any costs and expenses incurred in connection with the foregoing and shall be responsible for paying all fees and expenses in connection with recording the same.
4. This Assignment shall be governed in all respects, including the validity, construction, enforcement, interpretation and effect, by the substantive laws of the State of New York without regard to conflict of laws rules thereof.
