## ASSIGNMENT OF TRADEMARKS

ASSIGNMENT, made as of June 14, 2001 from CROWN PAPER CO., a Virginia corporation ("Seller") to TEMBEC USA LLC, a Delaware limited liability company ("Buyer").

### R E C I T A L S

WHEREAS, pursuant to an Asset Purchase Agreement dated as of June 1, 2001 (as amended to date, the "Asset Purchase Agreement"), between Buyer, Seller and certain other parties, Seller has agreed to sell, assign, transfer, convey and deliver to Buyer all of Seller's right, title and interest in and to the Purchased Assets (as defined in the Asset Purchase Agreement);

WHEREAS, in consideration for Seller's sale, assignment, transfer, conveyance and delivery of the Purchased Assets in accordance with the terms and conditions of the Asset Purchase Agreement, Buyer shall pay to Seller the Purchase Price (as defined in the Asset Purchase Agreement); and

WHEREAS, in connection with Buyer's acquisition of the Purchased Assets, Buyer desires to acquire, and Seller is willing to convey, Seller's entire right, title and interest in, to and under the trademarks, common law trademarks and trade names identified in Schedule A attached hereto (the "Trademarks") and all goodwill associated therewith, upon the terms and conditions of the Asset Purchase Agreement.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby assigns, transfers, conveys and delivers to Buyer all of Seller's right, title and interest in, to and under the Trademarks, together with all common law rights and the goodwill symbolized by and associated with the Trademarks, and all registrations and applications relating to the Trademarks, for its own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this Assignment had not been made; together with all income, royalties, fees and payments now or hereafter due or payable in respect of the Trademarks, and the right to file any action and recover damages by reason of past infringement, misappropriation or other unauthorized use of said Trademarks, with the right to sue for, and collect same for its own use and behalf, and for the use and behalf of its successors, assigns, or other legal representatives.

Seller hereby agrees to execute, acknowledge and deliver to Buyer all documents as may reasonably be necessary to make a record with any government agencies, courts or third parties of Buyer's ownership of all of Seller's right, title and interest in and to the Trademarks and the goodwill associated therewith.
