Assignment of Trademark

WHEREAS, Nylint Corporation, a corporation of the State of Illinois having its principal place of business located at 1800 Sixteenth Avenue, Rockford, Illinois, 61104, is the owner of the trademark registration and trademark application for an intellectual property known as "GEARHEADZ", trademark serial number 75869862, filed December 13, 1999, and further identified as set forth in Exhibit A, attached hereto;

and WHEREAS, Vap Creative, Limited, a limited liability company of the State of Ohio having its principal place of business located at 3721 Mohler Road, Cincinnati, Ohio, 45241, has a legal interest in "GEARHEADZ" pursuant to an "Exclusive License Agreement" between Nylint Corporation and Vap Creative, Limited dated November 22, 1999;

and WHEREAS, Nylint Corporation filed a Chapter 11 bankruptcy action in the United States District Court for the Northern District of Illinois, Western Division, which was assigned Case No. 01 B 70005 to Judge Manuel Barbosa;

and WHEREAS, Nylint Corporation as debtor-in-possession has rejected the "Exclusive License Agreement" dated November 22, 1999, which rejection has been approved by Judge Barbosa in an Entry dated May 14, 2001, terminating the "Exclusive License Agreement" effective May 14, 2001;

and WHEREAS, upon any termination of the "Exclusive License Agreement" dated November 22, 1999 the property and trademarks subject to the Agreement, including "GEARHEADZ", are to be assigned back to Vap Creative, Limited, such provision specifically surviving termination of the Agreement;

the parties agree as follows:

1. Effective May 14, 2001 Nylint Corporation does hereby irrevocably transfer, assign and convey to Vap Creative, Limited, its successors and assigns, all right, title and interest in and to the trademark registrations and trademark applications for the intellectual property known as "GEARHEADZ", trademark serial number 75869862, filed December 13, 1999, and further identified as set forth in Exhibit A, attached hereto, along with:

A. any renewals thereof;

B. all rights to prepare, apply for and register derivative marks;

C. and any and all good will symbolized by and/or associated with the business conducted under said trademark and any part thereof;

D. all income, royalties, damages, and payments due or payable in respect thereto on or after May 14, 2001, but excluding any royalties or income for trademarked items manufactured prior to May 14, 2001;

E. all causes of action, either in law or in equity, for past, present or future infringement based on such trademark;

F. all other rights corresponding to the foregoing throughout the world.

2. Nylint Corporation agrees to execute all papers and to perform such other acts as may be necessary to secure to Vap Creative, Limited the rights herein assigned.

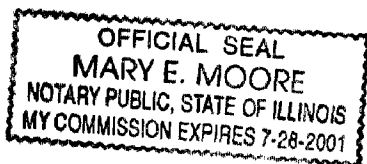
