

Deed of ASSIGNMENT

THIS DEED of ASSIGNMENT is made the 23rd day of March 2001

BETWEEN The Post Office, a UK Statutory Corporation whose principal office is at 148 Old Street, London, EC1V 9HQ, United Kingdom ("the Assignor")

AND Consignia plc a UK registered company (no. 4138203) whose registered office is at 148 Old Street, London, EC1V 9HQ, United Kingdom ("the Assignee")

WHEREAS

- A. The Assignor is the proprietor of a number of non-UK trade mark registrations and applications filed at local registries to register their marks, including those listed in the schedule hereto (hereinafter referred to as "the Trade Marks");
- B. It has been agreed, for the purposes of internal reorganisation between related companies, that the Trade Marks are to be assigned to the Assignee upon the terms hereinafter appearing.

NOW THIS DEED WITNESSETH AS FOLLOWS:

- 1. the schedule hereto, it is hereby confirmed that this Deed of Assignment covers all non-UK trade mark registrations and pending applications on file at the date shown above.


2. The Assignee hereby accepts the assignment of all rights hereby transferred.
3. At the request and cost of the Assignee, the Assignor shall execute all documents and do all such acts as may be reasonably necessary for the carrying out of this Assignment and to formally register it at national Patent Offices.
4. This Deed of Assignment shall be read and construed in accordance with English law and the parties hereto submit to the non-exclusive jurisdiction of the English Court.
